It is exciting to see the bridge coming into place on the east end of the neighborhood to connect the neighborhood to Lewisville Highway (5th East). This will make mowing easier in the summer and ensure a cleaner look for the neighborhood as a whole. Townhouse Maintenance Contract

As has been communicated previously, B&K took over the townhouse maintenance contract as of February 1. The monthly fee for maintenance is now \$120 per month for each townhouse. The Board has received some requests from townhouse owners to be excepted from the maintenance contract, but this has the potential to create unfair and unjust conditions for the rest of the townhouse owners. The Board has solicited input from townhouse owners via a survey and a meeting scheduled for April 5 (which will have already occurred by the time this newsletter is received). Results of the survey and the meeting will be distributed in additional communications.
